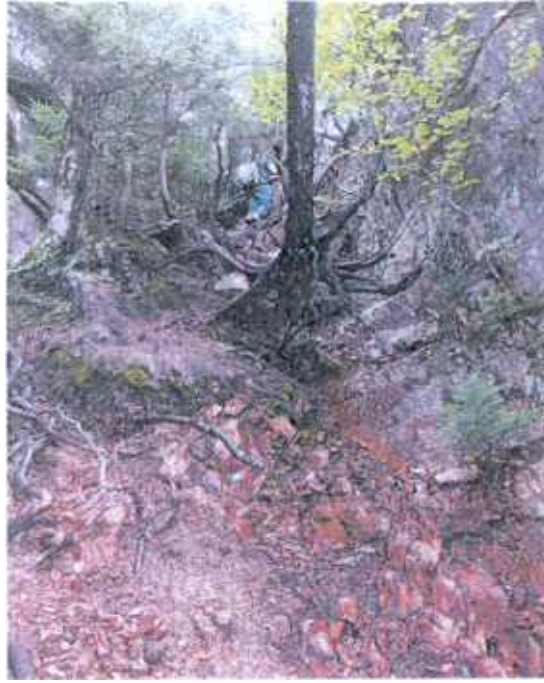

White Mountain National Forest Scoping Report Project Proposals for Two Trail Relocations on the Saco Ranger District

Introduction

The Saco Ranger District of the White Mountain National Forest (WMNF) is initiating a public scoping and environmental analysis process for two trail relocations on WMNF land. Both projects are described below under Purpose and Need and Proposed Action.

This report includes the Purpose and Need for the project, the Proposed Action, the Decisions to be Made, and How You Can Submit Comments to the Forest Service. The enclosed maps display the two relocations described herein.

Purpose and Need

The purpose of these two projects is to relocate two highly eroded and damaged segments of trail, on the Basin Trail near Basin Pond and the Lawrence Trail, onto more sustainable and appropriate terrain to prevent resource damage and improve recreation opportunities for trail users. The segment to be relocated on the Lawrence Trail poses a threat to public safety and is highly eroded with no viable option for repair using standard and accepted methods of trail stabilization. The Basin Trail portion is regularly subjected to overflows from nearby Basin Pond causing trail users to go off the trail to find drier ground and is also in need of a well-established stream crossing. This has resulted in negative resource impacts along the stream banks and areas adjacent to the current trail.

Proposed Action

The relocations are proposed to take place on .5 miles of the Lawrence Trail within the Sandwich Range Wilderness, and .3 miles of the Basin Trail in Evans Notch. The Lawrence Trail is in Management Area 5.1 and Basin Trail in Management Area 2.1. The proposed actions are consistent with management area direction for both areas, using standard trail building methods and tools in the construction of new trail. The Lawrence Trail will be constructed to Level 1 standards and the Basin Trail to Level II standards, as referenced in Forest Service Handbook 2309.18 and would be performed by Forest Service crews. The old segments of trail would be decommissioned which includes obscuring the trail with brush and removing blazes where present and stabilizing as necessary with drainage structures to reduce erosion impacts.

Decisions to be Made

Based on your input, on the recommendations of an interdisciplinary team of resource specialists, and on the requirements of the National Environmental Policy Act of 1969, Saco District Ranger, Terry Miller, as the Responsible Official, will decide whether the proposed action will proceed as proposed, as modified by an alternative, or not at all. If the project proceeds, he will determine what mitigation measures and monitoring requirements the Forest Service will apply to the project. He will also determine whether or not the project requires a Forest Plan Amendment.

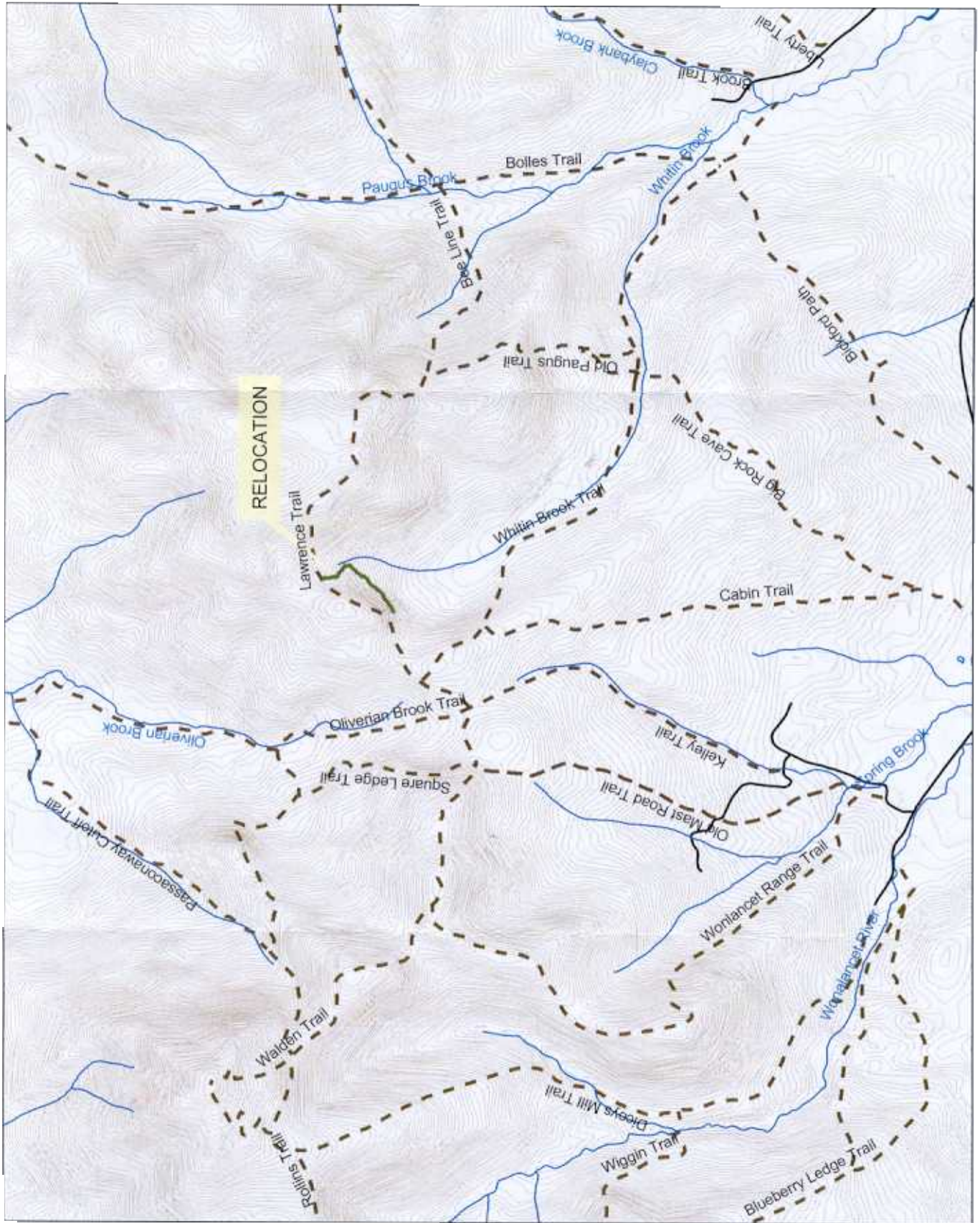

Comments must be submitted or mailed within thirty days after the postmark date of this letter's envelope, and should include the following information: Your name, address, and, if possible, your phone number and e-mail address.

- 1) The title of the project you are commenting on.
- 2) Your specific concerns and reasons the concern may lead to environmental effects.

The purpose of soliciting your comments during this scoping period is to collect additional information and to identify any unresolved issues regarding the proposal. To make your comments responsive they should be specific to the proposed action. Be sure to provide supporting rationale for your comments, including concerns about environmental effects of the proposed project. Please be aware that your name, address and comments will become part of the public record and may be available for public inspection.
